

## Outside Scholarships

Below is a list of scholarships applicable to MBA students organized by date as of September 2009. Scholarships without an available deadline date are listed at the end.

Jacob K. Javits Fellowships Program of the U.S. Department of Education - Undergraduate students about to enter graduate school and graduate students who have not yet completed their first year of graduate study and who intend to pursue a doctoral or master's degree may apply. Eligibility is limited to U.S. citizens or nationals, permanent residents of the U.S., or citizens of any one of the Freely Associated States. Deadline to apply is **October 2009**.

The Fulbright Scholarship offers awards to students who aim to increase mutual understanding between the peoples of the United States and other countries, through the exchange of persons, knowledge, and skills. Deadline to apply is **October 2009**.

Women in International Trade Northern California Scholarship Program will award \$2,000 to one qualified student with career aspirations in the field of international trade, business or policy. Awards are granted without regard to gender, race, religion, color, creed, age, disability, citizenship or national origin. Application deadline is **October 2009**. (<http://www.wit-nc.com>).

The American-Scandinavian Foundation (ASF) offers over \$500,000 in funding to Scandinavians to undertake study or research programs in the United States for up to one year. Also, the ASF offers fellowships (up to \$23,000) and grants (normally \$5,000) to individuals to pursue research or study in one or more Scandinavian countries for up to one year. Applicants must be US residents or permanent residents and have a well-defined research or study project that makes a stay in Scandinavia essential. The Paul and Daisy Soros Fellowships for New Americans is a \$20,000 maintenance grant and half of tuition for naturalized citizens or permanent residents who retain loyalty and a sense of commitment to their country of origin as well as to the United States and will continue to regard the United States as their principal residence and focus of national identity. Applications are due **November 2009**.

The Harvey Fellows is a stipend amount of \$16,000 per year, up to two years for incoming first year students. The fellowship is awarded to Christian graduate students attending a top five school to integrate their faith and vocation and pursue leadership positions in strategic fields where Christians tend to be underrepresented. The number of fellowships awarded each year varies according to available funds from the Mustard Seed Foundation.

Eligibility: Full-time, active student pursuing a hospitality-related degree at an accredited institution. Minimum grade point average of 3.3. Eligibility: Applicant must be a United States citizen OR a permanent resident of Polish descent AND be an undergraduate senior, an entering graduate student OR a current graduate student, AND have a minimum GPA of 3.0.
